Swim lessons are available for all ages but must be scheduled privately with one of the approved lifeguards. Swim lessons shall not be scheduled during normal pool hours.

Lifeguards

- Chenal Valley POA lifeguards are required to hold current Lifeguard and CPR certificates from an accredited agency.
- Chenal Valley POA lifeguards are also required to complete a Chenal Valley Pools lifeguard-training course.

- Lifeguards may pick up applications at the Chenal Properties Office beginning April 1, 2013
- Lifeguards are reminded to schedule their certification classes as early as possible.
